AUDIT RESULT - FIRST TRIMESTER (PHHA Auditor)

- As of April 30, 2024
 - Cash in bank = Php 344,354.56
 - Cash on hand = Php 10,000
- Issues still to be addressed:
 - Bank reconciliation as of December 31, 2023
 - Source of Php 105,360.90 cash which did not appear in ending balance as of Dec 31, 2023
 - Legal expenses

PROJECTS SPONSORED BY LGU & PROV'L GOV'T (Maintenance and Improvement Committee)

- Ph 1 Court Rehabilitation still waiting for the delivery of net and equipment
- CCTV and Solar lights awaiting delivery
- Outpost at Kamagong
- Lauan Perimeter Fence
- Ph 2 Children's Park
- Terminal Pavement at Ph 3
- PHHA Admin Hall still at the provincial government's Engineering department, programmed for implementation - no definite timeline, yet

UPCOMING PROJECTS TO BE INITIATED BY BOD (Maintenance & Improvement and Ways & Means Committees)

- Paid parking areas Estimated cost = Php 50,000 to be taken from the funds but can be recouped within 2 to 3 months
 - Ph3 open area fronting Cyber (11 slots)
 - Open space at the back of admin office (9 slots) while the proposed Admin Hall by Prov'l gov't has not started yet
 - Mr. Cabigting's property at Acacia corner Tindalo
- Weekend Bancheto at the Entrance Gate
- Little Ms Palmera timed for Palmera Heights' fiesta

SECURITY AND ORDER PROJECTS (Peace and Order Committee)

- Continuous installation of speed limit signage
- Installation of signage on PROHIBITED ACTS within Palmera Heights (Board Resolution #005-2024)
- One-way streets in Ph 1 exempted are the shuttle service
- Strict implementation of "no sticker, leave an ID" policy
- Replacement of motorcycle stickers to ensure only residents/members are issued the stickers

► STATEMENT OF ACCOUNT DISTRIBUTION - started on May 16, 2024

- 172 Members with more than Php 1,000 arrears
 - Phase 1 = 74
 - Phase 2 = 58
 - Phase 3 = 40
- Receivables until April MD = Php 550,000 (approx.)
- CONDITIONS STATED IN SOA
 - Payment within 60 days upon receipt of SOA, or
 - Arrange payment terms with BOD within 10 days upon receipt of SOA (payment term should not exceed 6 months, depending on amount)
- PENALTY FOR MEMBERS NOT IN GOOD STANDING
 - Non-collection of garbage
 - Non-issuance of gate pass, endorsements, Palmera Heights stickers
 - Not allowed to run in any elective position in PHHA
